


The Migration clearance rate for the year-to-date is 59%. The Refugee clearance rate for the year-to-date is 97%.






Migration, Refugee and combined decisions in the last 12 months




Decisions by outcome

Migration decisions by outcome


Refugee decisions by outcome






Refugee outcomes - UMA


